During fiscal year 2020 The Library Foundation celebrated 40 years of supporting the Louisville Free Public Library (LFPL). In 40 years the Foundation has raised more than 40 million dollars to support capital campaigns, a new book endowment, and educational programming for children, teens, and adults and much more. In FY20 alone 1.4 m dollars was granted to LFPL for books, technology, services and programs including much needed support of a new virtual Summer Reading Program for children. In the midst of a global pandemic Louisville's children were unable go to school or attend their favorite programs over the summer but the Foundation provided funds to support a new summer reading program that included book distribution at meal sites throughout Jefferson County. More than 50,000 books were given to library summer readers - books they were able to take home and keep forever. The Foundation remains committed to advocating for public and private dollars for and raising awareness of the many free services offered at LFPL.
