Part III Line 4a Program service accomplishments-In FY21, the Library Foundation provided \$856,667 in program support to the Louisville Free Public Library (LFPL). \$775,916 directly increased program capacity and the size of the borrowable library collection, including an additional 25,000 paper books, 8,500 ebooks, and 1,825 audiobooks. The Foundation also secured \$150,000 to place 50,000 "forever" books in the hands of over 10,000 Louisville toddlers. When in-person library classes and school counseling services were suspended due to the COVID-19 pandemic, a \$10,000 grant allowed the library to provide free ACT prep packages to 600 Louisville teens right in their homes. This year also saw the completion of a multi-year campaign to provide a new, state-of-the-art Louisville Free Public Library Children's Bookmobile for the city. Looking toward the future, the Library Foundation invested \$36,481 in a strategic planning process to advance its vision to advocate for public and private dollars and raise awareness of the many free services offered at LFPL.
